

Sirtex Medical Limited to be removed from the S&P/ASX 200 Index

SYDNEY, MAY 3, 2018: S&P Dow Jones Indices announced today that it will remove Sirtex Medical Limited (ASX: SRX) from the S&P/ASX 200, subject to shareholder and final court approval of the scheme of arrangement whereby the company will be acquired by Varian Medical Systems, Inc. (NYSE: VAR).

S&P Dow Jones will remove Sirtex Medical Limited from the S&P/ASX 200 effective at the open of trading on May 11, 2018. Sirtex Medical Limited will be replaced by IDP Education Limited (ASX: IEL) in the S&P/ASX 200 effective at the open on May 11, 2018.
