

## Insperty Set to Join S&P MidCap 400 and Eagle Bancorp to Join S&P SmallCap 600

**NEW YORK, November 13, 2018:** S&P Dow Jones Indices will make the following changes to the S&P MidCap 400 and S&P SmallCap 600:

- S&P SmallCap 600 constituent Insperty Inc. (NYSE: NSP) will replace LifePoint Health Inc. (NASDAQ: LPNT) in the S&P MidCap 400, and Eagle Bancorp Inc. (NASDAQ: EGBN) will replace Insperty in the S&P SmallCap 600 effective at the market open on Monday, November 19. Apollo Global Management (NYSE: APO) is acquiring LifePoint Health in a deal expected to close on or about that date pending final conditions.

Insperty provides human resources and business solutions to enhance business performance for small and medium-sized businesses. Headquartered in Kingwood, TX, the company will be added to the S&P MidCap 400 GICS (Global Industry Classification Standard) Human Resource & Employment Services Sub-Industry index.

Eagle Bancorp provides commercial and consumer banking services. Headquartered in Bethesda, MD, the company will be added to the S&P SmallCap 600 GICS Regional Banks Sub-Industry index.
