

MELROSE INDUSTRIES, HALMA AND KINGSPAN GROUP SET TO JOIN S&P EUROPE 350

- ams AG (XVTX: AMS) will be removed from the S&P Europe 350 and S&P Euro Plus indices.
- Melrose Industries PLC (XLON: MRON) will be added to the S&P Europe 350 and S&P United Kingdom indices.
- Halma (XLON: HLMA) will be added to the S&P Europe 350 and S&P United Kingdom indices.
- Kingspan Group Plc (XDUB: KSP) will be added to the S&P Europe 350 and S&P Euro indices.
