

ELISA CORPORATION AND ADP PROMESSES SET TO JOIN S&P EUROPE 350

- Effective at the open of **Thursday, January 3rd, 2019** Elisa Corporation (XHEL: ELISA) will be added to the S&P Europe 350 and S&P Euro indices.
- Effective at the open of **Friday, January 11th, 2019**, Shire Plc (XLON: SHP) will be removed from the S&P Europe 350 and S&P United Kingdom due to its acquisition by non-constituent Takeda Pharmaceutical Company Limited (XTKS:4502).
- Effective at the open of **Friday, January 11th, 2019** ADP Promesses (XPAR: ADP) will be added to the S&P Europe 350 and S&P Euro indices.
